Thomas Renz, Attorney

Thomas Renz is an Attorney affiliated with America's Frontline Doctors. He has a number of active cases he is handling against the Federal government and various State Governments concerning COVID and the violation of civil rights and religious freedoms, including the suppression and distortion of information.

Major Points

- 1. There is massive evidence of Federal and State governments lying to the American people, covering up Covid and vaccine information, and suppressing information.
- 2. The number of Covid cases and deaths has been deliberately reported as much higher than they really are to instill fear that will motivate the public to accept the loss of freedom and liberty.
- 3. The higher effectiveness of natural immunity that results from recovering from the Covid virus, versus the less powerful vaccine effectiveness is suppressed, and lied about.
- 4. There is massive neglect of patients in hospital treatment.
- 5. The lack of government-funded and sponsored research into Covid and vaccine effectiveness is completely inexcusable.
- 6. The push to vaccinate children is against the Government gathered data and scientific justification and must be resisted.

Mr. Renz explained that he has always been pro-vaccine and he got involved in filing legal cases because he felt that the lockdown was against our Constitutional rights and a major onslaught against individual freedoms. While researching the case he studied the Covid virus and the vaccine in great detail. The information he discovered shocked him and led him to file additional cases against Federal and State governments who he saw were lying about Covid and vaccine information and preventing the public from making informed decisions.

Mr. Renz explained that the Department of Health and Human Services modified the "Coroner's Handbook" to require that anyone who had Covid would be listed as dying of Covid no matter what the actual cause of death was (e.g., a motorcycle accident). In addition, hospitals and doctors were encouraged to diagnose Covid whenever possible, even if that was not causing the patient any symptoms or problems. In addition, the PCR test to diagnose Covid is designed to inflate the numbers of positives. All of this was done in order to create a fear in

the public at large to motivate them to take a vaccine that is also being forced on the public in a variety of manipulative and illegal ways.

A Department of Defense document that was obtained from a whistleblower was gone over in some detail. It contained statistics from CMS, The Center for Medicare and Medicaid Services, that presented data on Medicare patients that showed that:

- 80% of Medicare client deaths reported as of July of 2021 were of fully vaccinated patients.
- 71% of Covid cases among Medicare adults were in fully vaccinated patients.
- 48,000 deaths of Medicare patients that took place within 2 weeks of the individuals getting the vaccine were inappropriately not included in the morbidity rates which would lead to the impression that the vaccines were safe.
- When this data was made public by Mr. Renz in Court, the head of the CDC,
 Dr. Wilansky publicly admitted that the vaccine was ineffective against the
 Delta variant that is now going around.

Additional points that Mr. Renz discussed were that dark-skinned individuals have a higher Covid breakthrough rate, and this is not being addressed. He also found massive evidence of neglect of Covid patients in hospital settings

Finally, Mr. Renz addressed the issue of children being vaccinated. He pointed out that the lack of research into the safety of administering vaccines to children was unprecedented and unconscionable. The pressure being brought to bear on vaccinating children, despite the grave concern expressed by many in the medical and scientific community, he feels amounts to behavior that borders on crimes against humanity. He made the further point that these are the same people who are responsible for the lying and suppression of data and information that he presented earlier. He simply asked how we can now trust these same people and organizations now to tell us that children should receive the vaccines.
